Platte Land Trust Annual Report 2020

Mission: Protecting land, natural resources, and open space in the four-corners area of Missouri, Kansas, Nebraska, and Iowa for the benefit of today's communities and future generations.

Major accomplishments in 2020 included the following:

- Charlotte Sawyers Nature Area opened to the public to allow people more access to nature during the COVID pandemic.
- Four Eagle Award projects completed at CSNA.
- 520 Volunteer hours for land stewardship activities and projects
- Our all-volunteer and modest operation proved flexible and sustainable.

Land Conservation

Protecting Land Through Conservation Easements

The Platte Land Trust continued to monitor approximately 600 acres in conservation easement holdings.

- The National Golf Course (Parkville, MO) 270 acres in two golf courses
- The Frank Adams Farm (Jackson County, MO) 297 acres Missouri Century farm
- Sunflower Land Trust Mitigation Bank #1 (Wichita, Kansas) 30-acres of wetlands and creek restoration







Restoring Land at Platte Land Trust's Charlotte Sawyers Nature Area

PLT completed its fourth year of a ten-year land stewardship plan to remove invasive plant species and restore the grasslands and woods. This work continues with assistance from the Missouri Department of Conservation, Private Lands program and the dedication of PLT Board Directors and volunteers.

- Woodland thinning and cedar removal was completed in January and February.
- Evergy contractors sprayed the vegetation in the utility corridor in June.
- Spot spraying of invasive plants throughout the summer in the grassland areas.
- Invasive plant species removed along the west boundary with two volunteer groups.
- Debris piles were removed and the dam repaired in November.
- Prescribed burn was held December 28, 2020.







Programs and Projects


Volunteer Service

Volunteer community service activities resumed at Charlotte Sawyers Nature Area in the fall.

- Girl Scout Service Unit 605 cleared invasive plants along the west property boundary in September as part of their service to the environment.
- Cub Scouts from Union Chapel Elementary repainted the CSNA picnic tables in October.
- Northland Homeschoolers also cleared invasive plants from the west boundary during a fall volunteer workday.

Scout Award Projects

Scouts completed service award projects at CSNA starting in the summer with CDC and public health restrictions followed. Each project is of their choosing from a list of land stewardship and property improvements developed by the Land Stewardship committee.

Youth at Charlotte Sawyers Nature Area:

Charlotte Sawyers Nature Area (CSNA) is used for Scout troop camping once per month with advance registration. In 2020, camping occurred twice due to Scout program restrictions during the pandemic.

Northland Homeschoolers held a nature education program at CSNA in the fall.

Boy Scout Troop 393 planted a white oak tree at CSNA in honor of a fallen Scout.

Native Plant Sale:

The annual native plant sale was held September 12 at Backyard Bird Center on Barry Road. Sales of native plants were pre-order, pre-pay with curbside pickup due to COVID-19 restrictions. Fundraiser event for PLT supports operations and land stewardship. Many thanks to Mark McKellar and the staff of Backyard Bird Center and to Missouri Wildflower Nursery.

Annual Membership Meeting:

The Platte Land Trust's annual membership event was held November 8 as an Open House at our Charlotte Sawyers Nature Area. Board members and friends enjoyed a fall afternoon in nature with hikes and a campfire. CDC guidelines were followed during the event.

Family Time Outdoors and Summer Solstice

These programs were canceled in 2020 due to COVID-19 pandemic.

Strategic Plan 2025

The Platte Land Trust Board of Directors continued implementation of the 2025 Strategic Plan.

- Opened Charlotte Sawyers Nature Area to the public every Sunday in April to June to allow more people to enjoy nature during the pandemic restrictions.
- Started land protection discussions with six property owners to protect 535 acres.
- Added two Board Directors: Zachery Kramer and Carrie McCarthy.
- Initiated a master plan for the Charlotte Sawyers Nature Area.
- Prepared PLT for Land Trust Accreditation registration in 2021.

Sawyers Litigation

June 2020 culminated three years of litigation with the Tim I. Sawyers Trust and estate to recoup the costs incurred from the February 2017 fire that destroyed the house. Funds for the fire cleanup and legal counsel were paid from operating funds and stewardship reserve funds. The Board hired Levy Craig law firm to represent the organization with the intent of recouping our costs and the value of the house.

The judge ruled that Platte Land Trust has a valid claim against the estate of Tim Sawyers concluding PLT's legal action. As of December 31, 2020 PLT had not received funds from the Tim Sawyers estate or trust.
